

# BARNET COMMUNITY RESPONSE FUND Application Criteria and Terms & Conditions

As part of the community response to COVID-19, Barnet Together has set up a COMMUNITY RESPONSE FUND. The fund is being financially administered by Young Barnet Foundation on behalf of the partnership. The Fund is supported by Barnet Council and other stakeholders.

The fund has been set up to allow the community and businesses to donate to a central fund that will be used to support the community effort across the London Borough of Barnet and to allow us to respond to emerging need.

This fund is designed as a quick and easy way for community groups and charities operating within the London Borough Barnet to access the funds they need.

# What Can You Apply For? Small Grant

The fund is to support:

- Foodbanks (this could include food preparation/distribution and essential products to support our most vulnerable residents should needs present). We will be encouraging a partnership approach.
- Equipment to protect staff/volunteers in their work such. (for eg a wall mounted hand sanitizer).
- Additional funding to expand your service to support the COVID-19 response efforts and adapting services to meet emerging need.
- Other costs as deemed suitable by the Funding Panel.

#### The Main Grant

Funding may be used for

- Meeting emerging need
- Piloting a new initiative (with aim of using data to seek further funding)
- Upscaling of an existing project with proven track record
- Develop emotional wellbeing and resilience
- Enhance social inclusion

# Who is eligible to apply?

• Community, charity and faith groups delivering to support COVID-19 response efforts and adapting services to meet emerging need within the London Borough of Barnet. Groups should ideally have a two-signatory bank account. Should this not be the case please contact Young Barnet Foundation to discuss. **Individuals cannot apply.** 

#### How much can we apply for?

**Small Grants -** Up to £500 - (This may change depending on amount of donations.) **Main Grant Fund -** Up to £2000 - (This may change depending on amount of income)

#### How do we apply for?

Please select either Small Grants (up to £500) or Main Grant Fund (up to £2000) as the application forms are different.



# How often can we apply?

We will accept one application per round of funding.

## How do I apply?

By completing the online form, see link below.

#### How frequent will awards be made?

Funding will be released in waves whilst funding is available or until the funding panel deem that high need is no longer applicable. Funding is subject to donations being received. It will be the Funding panel's aims to share funding across the Borough but use centrally collected intelligence to aid decisions on which Foodbanks / areas of the borough are most in need of supplies/support.

#### **Environmental Impact**

We are encouraging applicants to consider the environmental impact of their projects and to reduce waste and recycle where possible.

Regarding face-coverings - consider making reusable face masks. Disposable PPE will no longer be covered by the funding.

#### How will payments be made?

Funds will be made via BACS to the bank account of the charity, community or faith group. It will also be possible to pay suppliers direct. For example, should a food wholesaler require immediate payment.

## Is this only for Young Barnet Foundation Members?

**NO** - this is on behalf of Barnet Together and open to <u>all groups supporting adults and children alike</u>. Young Barnet Foundation are a local grant giving organisation (<u>London Funders</u> Member) so best placed to financially administer the process. Young Barnet Foundation are providing their grant management free of charge to aid the community response.

#### Applications will be assessed against

- Evidence of need.
- Impact on the residents of Barnet.
- Financial need of the organisation and value for money.

#### **Funding Decision**

Providing the criteria is met then the Grants Manager will pass the application to the funding panel to ratify the award.

#### **Application Outcome**

**Small Grants -** Up to £500 - from closure of the round, it is anticipated this will be processed and paid within 5 working days.



**Main Grant Fund** - Up to £2000 Applicants will be told the outcome of their application within a maximum of 10 working days from round closure.

Further documentation will be required if a grant is awarded.

- Bank details request form.
- Signed T&C's with monitoring requirements.
- Policies such as Safeguarding policy (this is dependent on your application).


Payment will made within 5 working days of receipt of the above paperwork.

# **Monitoring and Evaluation Requirements**

**Small Grants -** Up to £500 - There are no formal monitoring and evaluation requirements, we may require proof of purchase, if the grant was to purchase items and/or .. pictorial evidence of the produce purchased to aid the campaign for more funds from the public and local businesses.

**Main Grant Fund -** Up to £2000 - It is recognised that robust assessment of applications and then monitoring and evaluation of approved projects is critical in assessing outcomes and we seek to balance this with the capacity and resource available to applicants. - dependent on project but to include numbers reached, areas, photos if applicable (This may change depending on amount of income)

# **Terms and Conditions**

These terms and conditions are BETWEEN: (1) Young Barnet Foundation of 102a Watling Avenue, Burnt Oak, London, HA8 0LN, registered charity no: 1164713 ("YBF"); and (2) The grant recipient which is, if the organisation named on the Bank Account Form is an incorporated entity, that organisation; and if the organisation named on the Bank Account Form is an unincorporated entity, the Delivery Agent named in the Application Form.



By submitting an application and accepting funding from the Community Response Fund, the applicant/grantee agrees to the following;

- Only one application/grant award will be made to an organisation per round of funding
- Barnet Community Response Fund is open until 31<sup>st</sup> December 2020 or until the total fund has all been allocated.
- We reserve the right to cancel the funding round early.
- We may increase the total amount in the funding pot at any time before the 31st December 2020.
- Being awarded funding for Barnet Community Response Fund will not restrict CYP member organisations for applying for future Space2Grow CYP Fund funding rounds.
- All applicants must agree to the monitoring and evaluation requirements.
- Failure to adhere to the monitoring and evaluation or reporting process may restrict future funding bids.
